The auditee was established on Aug 11, 2016 according to the business license. (According to the notice of registration for the establishment of business premises by the enterprise, the factory registered its current address in June 2023 and began operating at its current address in September 2023; Change the registered address of the business license in January 2024 to the current business address; So the environmental performance data reviewed in this audit covers the 12-month period from September 2023 to August 2024.)

The audited party specializes in the manufacturing of Wood and bamboo tableware. The main production processes include tooth cutting, magic cutting, molding, polishing, finished product inspection, and packaging.

Audited location information:

At the audit site, there are two buildings, all of which belong to Dalian Jinyuan Decoration Products Co., Ltd. The first building is Building 1 (production building) with two floors. The first floor was rented by the auditee and used asRaw material warehouse and production workshop (including include tooth cutting, magic cutting, molding, polishing, finished product inspection, and packaging). Half of the second floor was rented by the auditee and used as Storage of packaging materials warehouse and unused machines; The other half of the second floor is being used by the landlord Dalian Jinyuan Decoration Products Co., Ltd.

The second building is Building 2 (comprehensive building) with three floors. The first floor was rented by the auditee and used as office. The second and the third floors were used by the landlord (Dalian Jinyuan Decoration Products Co., Ltd) as office.

There is no business relationship between the landlord and the company, only a lease relationship. The audited party did not provide dormitories, canteens, and kitchens for the employees.

The main pollutants include atmospheric pollutants (particulate matter), domestic sewage, and general solid waste. Before emitting atmospheric pollutants, two sets of bag filters were used for centralized treatment, and the exhaust gas was discharged at high altitude through a 15M high exhaust pipe.

This site has no production wastewater. Before connecting to the municipal pipeline network, the domestic sewage undergoes pre-treatment in a three-stage septic tank.

At this site the Stationary Pollution Source Discharge Registration Form was established on 2023-08-18 and updated on 2024-11-13 and valid until 2029-11-12.

Worker number information:

The total number of employees was 95; 75 out of 95 employees were production staff.

Circumstances:

There was no special circumstance observed during this audit. The management personnel cooperated with the audit during the whole audit process.
